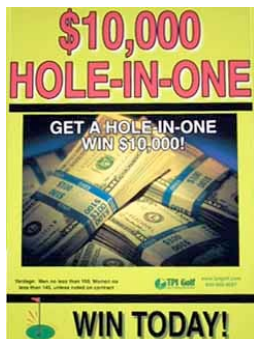

Putting Requirements:

- Min of 50'
- Need 1 witness over age of 18 stationed at the green.
- A Club Pro must be present and must verify footage.
- Must be video taped for review
- Measuring of length of final putt must be video taped.
- If contact if for 2 or more putters, each putt must be on a different line, at least 10' apart.

Other:

- No practice shots or professional golfers
- Winner must be registered at event.
- Putt must be on date of event.
- If cancelled due to weather, event can be rescheduled or refunded.

FULL TERMS:

TPI Golf Inc., hereby agrees to pay golfer(s) who achieved a Hole-In-One (referred to as Winner) up to the specified maximum prize value if Hole-In-One(s) occurring at Client's event. Such payment obligation is conditioned upon full compliance with each of the following conditions:

PRE-EVENT

- **PAYMENT** – Insurance premium must be paid by the party that registered the event (client) with TPI Golf. TPI Golf is not obligated to reimburse the winner for a prize if payment has not made by the client.
- **Target Hole:** Must be on a real green, no artificial greens allowed. Only one pre-designated hole may be used on the Target Green. Hole locations are not permitted in a "valley" or concave portion of a green. No side rails of grooves are permitted which would enhance the probability of a putt being made. **PIN MUST BE PULLED.**
- **Qualifying putts:** Must be made to a different hole other than the target hole or from another angle to the target hole. (I.E. no practice along same putting line.) Only Amateurs are eligible to win. All present and past Professionals are ineligible, and cannot compete for Prizes. A golfer will lose their amateur status if a prize is won.
- **Distance:** The final Target Hole will measure from the point where the putt is stroked to the flagstick, no less than 50' feet. Unless noted in contract. If two or more are putting, they cannot putt to the same hole from the same starting point. Starting points must be at least 10' apart. The Club Pro must verify the footage.
- **WITNESS** – Putt will be video taped (unedited), by a representative from the tournament. The tape MUST show the measurement of the final putt, the person putting, the cup they are putting towards, and the movement of the ball to the cup—ALL at the SAME time. Tape must show a clear view of the ball's movement towards cup. A representative from the Golf Course Pro Shop must be present to witness the putt. If prize amount is over \$10,000, two witnesses are required.
- **Putts:** A putt is a stroke as defined by the USGA Rules of Golf. No practice shots or mulligans are permitted at the Target Hole. Only one putt is allowed and only one putt is covered by this policy unless noted in the contract.
- **ELIGIBILITY** - A HOLE-IN-ONE must occur only by an officially registered golfer registered in the event, on the event date(s) registered by the client. Golfer must be an amateur; no present or past professional golfers.

AFTER EVENT

- **CLAIM NOTIFICATION** - Immediate telephone notice by client to TPI Golf (517-546-8557) no later than the first business day after the event.
- **PROOF OF CLAIM** – Client will furnish the following documentation as proof of HOLE-IN-ONE claim:
 - a. Attested statements by the target hole witness, the resident pro, and tournament director. (Forms will be furnished by TPI Golf).
 - b. Original unedited video tape.
- **Investigation** - Upon receipt of Proof of Claim, TPI Golf may conduct a reasonable investigation. The investigation may include polygraph examinations by a licensed American Polygraph Association member.

VARIABLE EVENT CONDITIONS

- Any changes in specific event data such as number of shots, hole yardage, dates, prize value, etc., REQUIRE NOTIFICATION TO TPI GOLF PRIOR TO THE START OF EVENT. AFTER NORMAL BUSINESS HOURS, CHANGES ARE REQUIRED IN WRITING VIA FAX (517) 546-6152.
- **WEATHER CONDITIONS:** Assuming no shots were taken on the target hole(s) a refund will be made. If event is canceled due to inclement weather, this insurance will be amended to a rescheduled rain date without additional charge. Partially completed events will either refund or credit unused shots on a pro rata basis.

Putt Fore Cash Video Instructions

Qualifying putts: Must be made to a different hole other than the target hole or from another angle to the target hole. (I.E. no practice along same putting line.)

Distance: The final Target Hole will measure from the point where the putt is stroked to the flagstick. **Length of the putt is 50'** unless noted on contract.

Target Hole: Must be on a real green, no artificial greens allowed. Only one pre-designated hole may be used on the Target Green. Hole locations are not permitted in a "valley" or concave portion of a green. No side rails of grooves are permitted which would enhance the probability of a putt being made. No claim can be unless a scheduled participant achieves the putt during the scheduled tournament, on the date of the event. **NEW!** The flag or practice flag on practice green **MUST** be removed from hole, or claim will be denied!

Putts: A putt is a stroke as defined by the USGA Rules of Golf. No practice shots or mulligans are permitted at the Target Hole. Only one putt is allowed and only one putt is covered by this policy.

Amateurs: Only Amateurs are eligible to win. All present and past Professionals are ineligible, and cannot compete for Prizes.

Video/Witness Process: MUST BE FOLLOWED OR CLAIM WILL BE DENIED!

1. Putt will be video taped (unedited), by a representative from the tournament. The tape **MUST** show the person putting, the cup they are putting towards, and the movement of the ball to the cup—**ALL** at the **SAME** time. Tape must show a clear view of the ball's movement towards cup.
2. **NEW!** Please show representatives measuring out the length of the putt.



The camera person should be behind the cup, with **full view of person putting, the ball, and the cup**. All need to be in the view finder and on the recording.

3. A representative from the Golf Course Pro Shop must be present to witness the putt.
4. **NEW!** The flag or practice flag on practice green **MUST** be removed from hole during final putt.

Proof of Claim: Client will furnish to TPI Golf the following: Name, address, and phone number where Winner can be reached and the unedited video. An affidavit will be required.
